Qualifying Products: Products must be ENERGY STAR certified. Verify that your smart thermostat is Energy Star certified by checking- www.EnergyStar.gov/products.

Rebate Amounts and Payments: Rebates will be \$50 per installation, limited to two per household, and cannot exceed 50% of purchase price. Rebate applications will be processed as they are received. Your rebate will be applied to your electric account in the form of a bill credit.

What is a Smart Thermostat? A smart thermostat is a Wi-Fi enabled device that can automatically adjust home temperatures (heating and cooling) for optimal performance. These devices can also be controlled with a smartphone or tablet to gain better control of energy efficiency. ENERGY STAR labeled smart thermostats offer energy saving, data, control, and convenience to home owners.

Verification: A copy of original sales receipt indicating brand, model, purchase date, purchase location, and price must accompany this rebate application. LELWD reserves the right to request documentation of having electric heat and/or central air. **Incomplete applications will be returned.**
